8. 8:15 PM **POLICY UPDATES**

ACTION

- A. First Reading Policies
 - a. 2190 Highly Capable Programs

WSSDA has revised this policy to comply with the legislation and to reflect the fact that school district practices for identifying highly capable students must prioritize equitable identification of low-income students.

- B. Second Reading of Policies
 - a. 1400 BP Meeting Conduct, Order of Business and Quorum

WSSDA has revised this policy with the overall goal of providing districts with more clarity about the operation of their board meetings and including more language addressing constitutional Considerations.

b. 2029 BP Animals as Part of the Instructional Program

This is policy that the board has previously not adopted. More situations are arising that need some board level policy guidance.

c. 3122 BP Excused and Unexcused Absences

WSSDA revised the policy and procedure to reflect revisions to VAC 392-401-020 and for more explicit alignment with the RCW 28A3225.

d. 3143 BP District Notification of Juvenile Offenders

WSSDA revised the policy for clarity and safety, and to ensure full compliance with the law.

e. 3144 BP Release of Information Concerning Student Sex and Kidnapping Offenders

WSSDA revised the policy and procedure for clarity and safety, and to ensure full compliance with the law.

f. 3241 BP Classroom Management, Discipline and Corrective Action WSSDA has revised the policy and procedure for the 2018-2019 school year, and will revise them again near the end of hte this upcoming school year in preparation for the 2019-2020 school year.

- g. 3413 BP Student Immunization and Life-Threatening Health Conditions
- h. 3416 BP Medication at School
- i. 3420 BP Anaphylaxis Prevention and Response

The revisions to the policies related to school nurses and student health add clarity, specificity, and correctly use the specialized terms. Other revisions include moving information from a policy to the procedure, or vise versa, to ensure that both policy and procedure play their best role.

j. 4500 BP Unmanned Aircraft Systems (Drones)

This is a new WSSDA policy that provides a clear statement prohibiting unauthorized use of drones and reserving the district's rights to remove or refuse entry to anyone engaged in unauthorized drone use. The policy also includes the necessary definitions, sets out the approval process, and reflects in the laws set forth by the FAA.

k. 6220 BP Bid Requirements

WSSDA revised the policy and procedure to be inclusive of both bid and proposal processes and to reflect that the Office of Federal Financial Management has raised the threshold for micro-purchases under federal financial assistance award to \$10,000 and raised the threshold for simplified acquisitions to \$250,000 for all recipients.

I. 6230 Relations with Vendors

WSSDA revised this policy to add that board members, administrators, and staff are prohibited from soliciting a gift or a favor from vendors, prospective vendors, other firms or individuals who have had or hope to have transactions with the district. The revision will help districts in an audit of program review.

m. 6610 BP Surveillance Cameras

The is a new WSSDA policy to deal with the purpose and process for using surveillance cameras.

n. 6630 BP Driver Training and Responsibility

WSSDA has revised this policy for clarity and for better alignment with the governing regulations. A section was deleted to increase consistency with other policies, procedures, guidelines, and practices regarding employees transporting students in district or private vehicles.
