 - a. 2255 Alternative Learning Experience Courses

WSSDA has updated this model policy and procedure to reflect recent revisions to the rules that govern Learning Experience (ALE). The revisions remove the requirement to obtain a parent or guardian's signature documenting their understanding of the difference between home-based instruction and ALE. However, the requirement to notify families of the difference between home-based and ALE programs at the time of enrollment still remains. These rule revisions became effective August 10, 2020, with the exception of the truancy section, which defines truancy protocol in ALE settings. The truancy section will take effect January 1, 2021. Any reference to the Choice High School has been removed because CHS is no longer an ALE program.

b. 3143 Policy Notification and Dissemination of Information about Juvenile Offenses and Threats of Violence

Dissemination of Information about Juvenile Offenses and Threats of Violence. This new version of 3143 is retitled Model Policy, Procedure, and Form 3144/3144P/3144F and Model Policy and Procedure 4314/4314P. WSSDA has also revised Model Policy 3120–Enrollment, which is an essential policy to reflect HB 1191.
