You can influence the success of your child by becoming an active participant in your child's school:

Title I, Part A provides financial assistance to states and school districts to meet the educational needs of students at-risk of failing the state's challenging performance standards in mathematics, reading and writing. Additional instructional services and activities that support students include:

- Teaching materials that supplement a student's regular instruction.
- Teacher and instructional aides.
- One-to-one or small group instruction.
